To the Temporary Service List:

I forwarded to you yesterday a number of emailed comment letters that the Siting Board received earlier this week. Each of the comment letters is identical in content, although each has been submitted and signed by a separate individual. As of today, I estimate that the Siting Board has received well over 100 of these "form" comment letters. None of the letters were filed with DPU-Efiling or served on the temporary service list.

Because of the volume of the form comment letters and because each is exactly the same in content, it is not a sensible use of agency resources to forward all of these letters to each person on the temporary service list individually. Accordingly, I will not be forwarding any more of these comment letters to you. (I will continue to forward future comment letters as they are filed).
