As dispatch was sending officers to check on the numerous locations, Detective Jesse Fabian called over the air and said he received a call from a family member who was also reporting a fire at 79 Durso Ave. I made my way to 79 Durso Ave and confirmed that there was an active basement fire. Detective Fabian and I made our way over to investigate the explosion. Upon arrival to 35 Chickering Street, I observed the house was completely leveled by the explosion. I called in our location and informed dispatch that we had a house explosion with people trapped inside. I walked towards the house and could hear a female screaming for help. I crawled through a collapsed wall in the front of the house and found an older female asking for help with her daughter who was trapped inside. then made my way back inside the house. Inside the house, I was able to locate a younger female who was trapped by debris. I removed the debris covering the female and noticed she had compound fractures to her lower legs. I called out to Detective Fabian and Officer Lakin to help me with removing the female from the house. I was able to hand off the female to Detective Fabian, Officer Lakin and Detective Gonzalez through an open window. The female was brought to an arriving LGH ambulance crew for further treatment.

top of a vehicle that was crushed by a chimney that fell from the explosion. Officer Carmichael, Officer Trainor and Officer Lakin where attempting to lift the chimney off of the vehicle due to the driver being trapped inside. I opened the rear passenger door to render assistance to the trapped driver. Several fire fighters arrived and instructed us to step away due to the gas line being severed and still actively flowing gas from the house. The fire fighter said he was worried about a secondary explosion and to back away. My attention was then drawn to two males who stated they were seated inside of the crushed vehicle and appeared injured. I had both males leave the driveway and escorted them over to the ambulance on scene. (Continued on next page)
