Dear Secretary Marini:

The distribution company members of the Customer Assistance Working Group¹ are writing to follow up on a recommendation offered by the Working Group in its May 29, 2020 Report to the Department of Public Utilities (the "Department") regarding the end of the current Shut-Off Moratorium for commercial and industrial ("C&I") customers. The Working Group recommended in the Report that the current Shut-Off Moratorium for commercial customers end on September 1, 2020 in order to encourage those C&I customers who can pay to begin paying down arrears and arrange for a payment plan prior to the winter moratorium, as needed.

The Distribution Companies fully acknowledge that the Working Group's recommendation on this issue is currently before the Department and is pending review. To the extent the Department were to approve the recommendation, the Distribution Companies would need to commence shut off notifications on/about August 4, 2020. Accordingly, any guidance the Department is able to offer before that date regarding the end of the current C&I Shut Off Moratorium would be greatly appreciated to facilitate customer outreach.

The Distribution Companies are eager to roll out the next phases in their Customer Outreach Plan, in coordination with the full Working Group, and in a manner fully consistent with guidance from the Department. The Distribution Companies have been authorized to represent that the Office of the Attorney General and AIM support their request, and that the DOER and NCLC have no objection.
