


Re: Inquiry into Establishing Policies and Practices for Electric and Gas Companies,

Dear Secretary Marini:

On December 31, 2020, the Department of Public Utilities (“Department”) issued an interim decision in the above-referenced docket regarding the ratemaking proposal submitted to the Department on August 5, 2020, by the Ratemaking Working Group convened in the above-referenced proceeding.<sup>1</sup> In the interim decision, the Department directed the Distribution Companies to make a compliance filing on Friday, January 22, 2021. Order at 21. To coordinate a response between the Distribution Companies and the AGO, additional time is required. The Distribution Companies have conferred with the AGO and expect to submit the compliance filing to the Department no later than Friday, January 29, 2021.<sup>2</sup>
