NOTICE OF PUBLIC HEARING AND REQUEST FOR COMMENTS

D.P.U. 21-77 September 21, 2021

Petition of the Town of Andover for approval by the Department of Public Utilities of a municipal aggregation plan pursuant to G.L. c 164, § 134.

On July 9, 2021, the Town of Andover ("Town") filed a request with the Department of Public Utilities ("Department") for approval of a municipal aggregation plan pursuant to G.L. c. 164, § 134. General Laws c. 164, § 134 authorizes a municipality to procure electric supply on behalf of consumers within its municipal borders through a municipal aggregation program ("Program"). Eligible electricity consumers not already enrolled with a competitive electric supplier would be automatically enrolled in the Program unless they chose to opt-out, in which case they would continue to receive basic service provided by their electric distribution company, Massachusetts Electric Company, d/b/a National Grid. The Department docketed this petition as D.P.U. 21-77.

The Town has retained Good Energy, L.P. to serve as its agent and consultant in this proceeding and to assist in the implementation of the Program. The Town seeks a waiver on its own behalf and on behalf of the competitive electric supplier(s) chosen for the Program, of certain information disclosure requirements contained in G.L. c 164 § 1F(6) and 220 CMR 11.06(4)(c).

Due to certain ongoing safety measures and precautions relating to in-person events as a result of the COVID-19 pandemic, the Department will conduct a virtual public hearing to receive comments on the Town's filing. The Department will conduct the hearing using Zoom videoconferencing on Thursday, October 21, 2021 beginning at 2:00 p.m. Attendees can join by entering the link, https://us06web.zoom.us/j/84999899064, from a computer, smartphone, or tablet. No prior software download is required. For audio-only access to the hearings, attendees can dial in at (646) 558-8656 (not toll free) and then enter the Meeting ID# 849 9989 9064. Thursday, October 21, 2021. To the extent a person wishes to submit comments in accordance with this Notice, electronic submission, as detailed below, is sufficient.

All written comments or other documents should be submitted to the Department in **PDF format** by e-mail attachment to <u>dpu.efiling@mass.gov</u> and <u>stephanie.mealey@mass.gov</u>. In addition, all written comments should be emailed to counsel for the Town's agent, Scott Mueller, Esq., at <u>scott.mueller76@gmail.com</u>. The text of the e-mail must specify: (1) the docket number of the proceeding (D.P.U. 21-77); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document. All documents submitted in electronic format will be posted on the Department's website as soon as practicable at http://www.mass.gov/dpu. The e-mail must also include the name, title, and telephone number of a person to contact in the event of questions about the filing. Importantly, all large files must be broken down into electronic files that do not exceed 20MB.

At this time, all filings will be submitted only in electronic format consistent with the Commission's June 15, 2021 directive related to modified filing requirements. Ordinarily, all parties would follow Sections B.1 and B.4 of the Department's Standard Ground Rules (D.P.U. 15-184-A, App. 1 (March 4, 2020)); however, until further notice, parties must retain the original paper version and the Department will later determine when the paper version must be filed with the Department Secretary.

The Town's filing and all related documents submitted to or issued by the Department will be available at the Department's website as soon as is practicable at https://eeaonline.eea.state.ma.us/DPU/Fileroom/dockets/bynumber (enter "21-77"). A paper copy of the filing will not be available for public viewing at the Town's offices or the Department due to certain ongoing safety measures and precautions relating to in-person events as a result of the COVID-19 pandemic. ORDER OF NOTICE

D.P.U. 21-77 September 21, 2021

Petition of the Town of Andover for approval by the Department of Public Utilities of a municipal aggregation plan pursuant to G.L. c. 164, § 134.

The Town of Andover ("Town") shall, not later than **September 27, 2021**, publish the attached Notice of Filing and Public Hearing ("Notice") in (1) either The Boston Globe or the Boston Herald; and (2) the Eagle-Tribune. In addition, not later than **September 24, 2021**, the Town shall serve a copy of the attached Notice on the Attorney General of the Commonwealth of Massachusetts, the Massachusetts Department of Energy Resources, and Massachusetts Electric Company, d/b/a National Grid. Such service may be by electronic distribution, which the Department finds reasonable and consistent with the public interest. Finally, the Town shall from **three days** following the receipt of the Notice from the Department through **October 21, 2021** prominently display the attached Notice on the Town's official website and the Program website, as well as any additional locations where the Town typically publishes local notices.

The Town is directed to make proof of publication (including posting on the Town's website) and return of service not later than the close of business (5:00 p.m.) on **October 19, 2021**.
