## I. <u>INTRODUCTION</u>

On January 13, 2023, the Distribution Companies<sup>1</sup> submitted to the Department of Public Utilities ("Department") their fourth quarter 2022 report on the Small Commercial Arrearage Forgiveness Program ("AFP"). The Distribution Companies requested that the

#### II. BACKGROUND

## A. <u>Inquiry Related to Customer Assistance and Ratemaking In Response to</u> <u>COVID-19 Pandemic</u>

On May 11, 2020, the Department opened this inquiry into establishing policies and practices regarding customer assistance and ratemaking measures for jurisdictional electric and gas companies in response to the effects of the novel coronavirus ("COVID-19") pandemic. <u>Policies and Practices for Electric and Gas Companies Regarding Customer</u> <u>Assistance and Ratemaking Measures in Connection to the State of Emergency Regarding the</u> <u>Novel Coronavirus ("COVID-19") Pandemic</u>, D.P.U. 20-58 (May 11, 2020) ("NOI"). The Department established the Customer Assistance and Ratemaking Working Group ("Working Group")<sup>2</sup> to assist the Department in establishing appropriate policies and practices relating to the customer assistance and ratemaking measures. <u>NOI</u> at 4. Regarding potential customer assistance measures, the Department requested that the Working Group deliberate over

Eversource Energy, NiSource, Inc., Bay State Gas Company, Eversource Gas Company of Massachusetts, D.P.U. 20-59/D.P.U. 19-140/D.P.U. 19-141 (2020). certain proposals, including one for extended arrearage management plans, with a goal to develop consensus recommendations for the Department. NOI at 7-8.

#### B. <u>Small Commercial Arrearage Forgiveness Program</u>

On August 12, 2020, the Working Group submitted a pro forma AFP intended to encourage small commercial customers to enroll in and successfully complete a payment plan with a duration of up to twelve months (August 12, 2020 Cover Letter at 1). The encouragement would be the reduction of the amount of accrued arrearages of eligible small commercial customers and a prohibition on late payment charges and disconnection for the duration of the customer's payment plan (AFP, §§ A- C).<sup>3</sup> On September 3, 2020, the Department approved the pro forma AFP, and required each Distribution Company to make a compliance filing consistent with the pro forma AFP. D.P.U. 20-58-C at 8, 10 (2020).<sup>4</sup>

#### 1. <u>Term of the AFP</u>

The Department determined that the AFP would be available until December 31, 2020 (or March 31, 2021 for The Berkshire Gas Company), but that a Distribution Company could seek an extension of its AFP. D.P.U. 20-58-C at 3, 8. The AFP was extended through April 1, 2021 (D.P.U. 20-58, Stamp-Granted Joint Motion to Extend the AFP (December 22, 2020)), and later through June 30, 2021 (D.P.U. 20-58, Stamp-Granted Joint Motion to Extend the AFP (April 2, 2021)). The Department granted National Grid an extension of its AFP through September 30, 2021. D.P.U. 20-58, Stamp-Granted Motion of National Grid to Extend the AFP (June 30, 2021).

## 2. <u>AFP Reporting Requirements</u>

The Department directed the Distribution Companies to submit quarterly reports to the Department which would contain specific information regarding each Distribution Company's AFP. D.P.U. 20-58-C at 6, 8, 10. The Distribution Companies have continued submitting

#### III. DETERMINATION OF AFP REPORTING REQUIREMENTS

Having conferred with the Commission regarding the Distribution Companies' request to cease the quarterly reporting of the AFPs, the Department determines that, effective immediately, the Distribution Companies are not required to file AFP quarterly reports with the Department. The Department makes this determination based on (1) the expiration of the extended term of the AFP as documented above; and (2) the Distribution Companies' representations that they have ceased enrollment in the AFP and have no active customers in the AFP (January 13, 2023 Cover Letter at 1); see, e.g., Distribution Companies' Fourth Quarter 2022 Report on the AFP (January 13, 2023). The Department may revise this discontinuation of AFP reporting as warranted by changed circumstances.
