Dear Secretary Marini:

On behalf of NSTAR Electric Company d/b/a Eversource Energy (“Company”), please find enclosed the Company’s corrected monthly arrearage tracking spreadsheets for December 2022 to March 2023, pursuant to D.P.U. 20-58-A. Upon further review of the NSTAR Electric-East data file for these months, the Company determined that Sections 6, 7, 8, and 9 require corrections to the data reported for the months of December 2022 through February 2023. The Company is filing the April 2023 spreadsheet under separate cover.

The Company is providing plain ‘Corrected’ copies and ‘Corrected and Highlighted’ copies for your records. The Company offers the following reasons for the corrections, as demonstrated through color-coding in the ‘Corrected and Highlighted’ copies. Cells highlighted in green are being changed due to an error in pulling information from incorrect source detail in the original filings; these cells have been corrected as of the initial March 2023 filing. Cells highlighted in yellow are being changed due to another error in pulling information from incorrect source detail in the original filings; these cells have been corrected as of the April 2023 filing submitted under separate cover. The cell AV64 highlighted in blue is being changed because the Company inadvertently hardcoded a previously reported total value despite the value changing due to other corrections.

For avoidance of doubt, the Company acknowledges that differences between cumulative sub-totals and reported totals of one dollar in value are due to rounding errors.
