Friday, February 24	Eversource files supplemental responses to EFSB-RR-54, regarding Project Cost.
Friday, March 3	EFSB Staff issues 3 rd set IRs to Eversource re Eversource's supplemental responses to EFSB-RR-54.
Monday, March 6	Eversource requests and is granted a one-week extension, to March 17, 2017, to respond to Staff's 3 rd set IRs.
Wednesday, March 8	Conference call with parties to discuss Possibility of additional process re Eversource supplemental Cost responses.
Friday, March 10	Channel Fish to file request for supplemental responses to existing Eversource IR responses (other than Cost-related responses); Channel Fish will include list of specific IRs for which supplemental responses are requested.
Tuesday, March 28	(1) Eversource files responses to Staff 3 rd set IRs; (2) Eversource files response to Channel Fish March 10 filing requesting supplemental IR responses.
	Note: A ruling on Channel Fish's March 10 motion will be issued expeditiously. If the ruling is granted in whole or in part, it will include a date by which Eversource is to file the supplemental responses. If it wishes to do so, Eversource may suggest in its response

Channel Fish files supplemental Cost IRs.

Tuesday, April 18

Eversource files responses to Channel Fish supplemental Cost IRs.

Tuesday, 25

Channel Fish renews request for additional day of hearings re Cost, or indicates that no additional day of hearings will be requested.

Friday, April 28

If Channel Fish has requested an additional hearing day, ruling is issued on request. If request is granted, hearing date scheduled as expeditiously as possible.

Note: If (1) an additional day of hearings is requested and request is granted, or (2) a ruling on the request cannot be issued by April 28, the remaining schedule will be adjusted appropriately. However, the parties have agreed to proceed at this time in accordance with the listed dates.

Tuesday, May 2,

If no additional day of hearings is held, Channel Fish to file any additional briefing re Project Cost. If an additional day of hearings is held, briefing schedule to be determined at the hearing.

Tuesday, May 9

If no additional day of hearings is held, Eversource to file any additional briefing re Project Cost. If an additional day of hearings is held, briefing schedule to be determined at the hearing.
